## Safe Shopping

We fully appreciate your concerns about transmitting personal information over the Internet. Safeguarding your privacy and confidentiality is of the utmost importance to us. Therefore, we use the Secure Sockets Layer (SSL) protocol for payments, which encrypts (scrambles) your information as it crosses the myriad wires, switches and routers that comprise the Internet. The information is de-encrypted (unscrambled) only after it arrives on our secure commerce server. This basically puts any "would-be" hackers out of business.

#### **Credit Cards**

For any transactions on abstractpaintings.eu which require a credit card or debit card, abstractpaintings.eu stores the last four digits of the credit/debit card number, the expiration date, and the buyer's name. We do NOT store the full credit card number, pin number, CVV2 number, or any full-track data.

## Security

# Log Files

abstractpaintings.eu follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this as a part of hosting services' analytics.
